Thermography Services

Installations in good condition should last for years without significant deterioration, whereas other areas in hazardous locations or previously stressed equipment will have limited life that requires monitoring. TechCompServicesTM provides thermography services to monitor and skilfully interpret infrared imaging to see what cannot normally be seen. Our Thermographers are trained (level 1 accredited) and experienced in the areas of Condition Monitoring for electrical diagnostics.

Driven by Maintenance Management, Insurance Risk Management and O H & S issues, thermography services apply to all electrical infrastructures, both high and low voltage (i.e., power generation & transmission, substation inspections including transformers, switchgears and circuit breakers, electrical switch boards and electrical motor inspections). TechCompServicesTM also provides thermography

services to monitor mechanical systems. This reduces the risk of an unexpected breakdown and costly interruption to operations.

TechCompServicesTM also provides thermography services for thermal diagnostics of buildings. The high (and rising) energy costs of Australia are increasingly driving this application. We can:

- ✓ locate missing or damaged insulation of buildings
- ✓ Identify cooling air leakage losses
- ✓ Cold Storage cooling losses.
- ✓ Detect insulation leaks in refrigeration equipment

TechCompServicesTM conducts a fixed price site wide audit of installed base to identify and classify each installation into 4 classifications, Critical, Monitor, Maintain and Review.

- ✓ <u>Critical</u> classified equipment will be reported upon completion of audit and all images are retained for future baseline comparison by TechCompServicesTM. A report containing critical information is handed to client for action in line with client policy.
- ✓ Monitor classifies areas that show significant anomalies but do not require immediate action.
- ✓ <u>Maintain</u> are those areas that are deemed critical and could propose financial or operational risk if failure occurred.
- ✓ Review are areas deemed to be stable with no likelihood of foreseeable issues.

The initial classification of equipment means that a programmed approach to intervals between inspections for each piece of equipment can be decided that is inline with risk tolerance matrix of each site preventative maintenance strategy. The clients are then able to schedule and carry out their own repairs according to priorities.
